

EVENT AND RIDE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT



I (AS AN UNDERSIGNED) HEREBY RELEASE, WAIVE DISCHARGE AND COVENANT NOT TO SUE the promoter, club, participants, association, sanctioning organization or any subdivision thereof, grounds operator, grounds owner, officials, any persons in any restricted areas, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as "releases", from all liability to me, my personal representatives, assigns, heirs and next of kin for any and all loss or damage, and any claim or demand thereof on account of injury to me or property or resulting in my death whether caused by the negligence of the releases or otherwise while I am in or upon the restricted area, and/or, competing, officiating in, observing, working for, or for any purpose participating or riding in the event;

I (AS AN UNDERSIGNED) HEREBY AGREE TO INDEMNIFY AND SAVE HOLD HARMLESS the releases and each of them from any loss, liability, damage, or cost they may incur due to my presence in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event or ride whether caused by the negligence of the releases or otherwise.

I (AS AN UNDERSIGNED) HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of releases or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purposes participating in the event or event ride.

I (AS AN UNDERSIGNED) expressly acknowledge and agree that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage. I further expressly agree that the forgoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as in permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall not with standing, continue in full legal force and effect.

I (AS INDICATED AS AN UNDERSIGNED) HAVE READ AND VOLUNTARILY SIGN THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agree that no oral representations, statements or inducement apart from the forgoing written agreement have been made.
